## 1. SIDES

- 1.1. - 1.2. From other side [http:// www.altincuzdan.com](http://www.altincuzdan.com) website's (Referred as "İnternet Website".) registered users (Referred as "User".)

## 2. THE PURPOSE OF AGREEMENT

- 2.1. The purpose of the Agreement is to determine the terms and conditions associated with the usage of the website by the user.

## 3. TERMS OF USE

- 3.1. People under the age of 18 cannot trade on the website. By using website and / or registering on it, the user declares and accepts that she/he is over 18 years of age.
